Terms and Conditions

1. **Retainer and Payment.** The Client shall make a non-refundable _____ dollar retainer to retain the Photographer/Videographer to perform the services on the date and place specified herein. The Client shall agree to pay the balance in full on or before the day of the wedding.
2. **Cancellation.** If the Client cancels wedding date or does not perform wedding on the agreed upon wedding date, liquidated damages for the full amount of contract shall be due and owing from said client. Client agrees that Initial retainer made during prior to agreed upon wedding date **TO BE NON-REFUNDABLE.**
3. It is understood and agreed that no other photographer will be allowed to photograph or take pictures at the wedding while the photographer is working.
4. **Copyright and Reproductions.** The photographer/videographer shall own the copyrights for the photos/video created and shall have the exclusive right to make copies of them. It is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of the Photographer and may be used for advertising, marketing materials, display or any other purpose thought proper by the studio. Upon final payment by the CLIENT, **limited** copyright ownership of the resulting images will be transferred to the CLIENT under the following conditions:
The images on CD/DVD are the property of CLIENT for personal use and for the purposes of the reproduction and giving of photographs to friends and relatives.
The Client must obtain written permission from and compensate Eric Baillies (Photographer) prior to the CLIENT or its friends and relatives publishing or selling the photographs for profit.
5. **Failure to Perform.** If the Photographer/Videographer cannot perform this Agreement due to a fire or other casualty, or other causes beyond the control of the parties, or due to the Photographer/Videographer illness then Elite Video Photo shall – (1.) Return to the Client any retainer made prior to the wedding date and shall (2.) Have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that the photos are lost through camera malfunction, or otherwise lost or damaged without fault on the part of the Photographer/Videographer. In the unlikely event the Photographer/Videographer fails to perform pursuant to the terms of this Agreement for any other reason, including but not limited to problems with exposure, duplication, or delivery, Photographer/Videographer shall not be liable for any amount in excess of the retail value of the Client's order.
6. **Credit.** Photographer/Videographer reserves the right to use company logo, name and any other labeling on the CD/DVD photo proofs as well as any other packaging.
7. **Miscellaneous.** This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. This Agreement shall be governed by the laws of the State of Wisconsin.
